Marche is 17 and completing grade 12 at Charles Best Secondary School. He has alcohol related neurodevelopmental disorder, Tourette syndrome, attention deficit hyperactivity disorder, obsessive-compulsive behavior, and significant learning disabilities. He is continuing to take sustained release Ritalin 20 mg morning and noon and tetrabenazine 12.5 mg morning and noon. He receives his medication from his pediatrician, Dr. Susan Kalaher.

Marche's parents separated at the end of April, and Marche and his mother moved into a large one-bedroom apartment. Marche's father has chosen not to have contact with Marche at this time. Marche was quite upset that he did not come to his graduation. Marche is currently starting to be more angry and irritable, arguing with his mother and presenting with an aggressive stance. However, he did choose to come home after being with his friends for only an hour and a half when they started to use marijuana.

Marche says that he sleeps okay but his mother sometimes find him up reading at 3:00 or 4:00 in the morning. His tics will increase with stress and also he sometimes forgets to take his medication. He also plays with his fingers and picks at his face. He sometimes gets fairly severe headaches and uses Tylenol for them.

Marche's mother has looked into getting financial support to help with Marche's medication and Marche is also on the waiting list to have a childcare worker. Hopefully this will occur before the end of the summer and I strongly recommend
